MEMORIAL NARDINO PREVIDI **REGULATION UNDER 17**

ART. 1 ORGANIZATION

PCS SANMICHELESE SSD ORGANIZES AN INTERNATIONAL TOURNAMENT DENOMINATED: "9TH MEMORIAL NARDINO PREVIDI" WITH THE PATRONAGE OF THE MUNICIPALITIES OF SASSUOLO (MO), CASALGRANDE (RE), FIORANO MODENESE (MO) AND MODENA, WHICH WILL BE DISPUTED IN THE DAYS OF THURSDAY '30 AND FRIDAY 31 AUGUST, SATURDAY 1 AND SUNDAY 2 SEPTEMBER 2018, AT THE SPORTS FACILITIES, STADIUM "ANGELO CORRADINI" VILLALUNGA "(RE), STADIUM" MUNICIPALITY "GRAZIANO FERRARI (MO), STADIUM" E. RICCI "SASSUOLO (MO), STADIUM G.ZANTI SASSUOLO, AND STADIUM" MANFREDINI "SALICETA SAN GIULIANO (MO).

ART. 2 PARTICIPATION CATEGORY AND AGE LIMITS

THE TOURNAMENT IS RESERVED TO THE CATEGORY UNDER 17, REGULARLY UNDER CONTRACT WITH ITS COMPANY AND NATIONAL FEDERATION FOR THE SEASON IN PROGRESS.
UNDER 17 BORN FROM 1 JANUARY 2002 TO THE ANAGRAPHIC COMPOSITION OF THE 14TH YEAR OF AGE

ART. 3 LOANS

LOANS ARE ALLOWED, IN MAXIMUM NUMBER OF 3 (THREE) FOR EACH TEAMS, NOT INTERCHANGEABLE AND VALID FOR THE ENTIRE DURATION OF THE TOURNAMENT. PREVIOUS PRESENTATION TO REGULATE AUTHORIZATION RELEASED BY THE FOOTBALL TEAMS THAT WILL NOT PARTECIPATE TO THE TOURNAMENT

ART. 4 PLAYERS LISTS

THE PARTICIPATING FOOTBALL TEAMS WILL HAVE TO PRESENT AT THE ORGANIZATION OF THE TOURNAMENT, BEFORE ITS BEGINNING, THE LIST OF THE SOCCER PLAYERS WHICH INTEND TO USE, UP TO A MAXIMUM OF N ° 20, AFTER THE OCCURRENCE OF DELIVERY IS PROHIBITED TO MAKE CHANGES TO THESE LISTS.
IN THE DISTINCTION TO BE PRESENTED TO THE REFEREE BEFORE THE RACE WILL BE INDICATED UNTIL A MAXIMUM OF PLAYERS 20

ART. 5 SUBSTITUTIONS

WILL BE ALLOWED n°7 REPLACEMENTS, INDEPENDENTLY FROM THE ROLE, AT ANY TIME OF THE GAME

ART. 6 PARTICIPATING COMPANIES

ART. 7 TOURNAMENT FORMULA

THE TOURNAMENT WILL TAKE PLACE WITH THE FOLLOWING FORMULA:

THE 12 TEAMS ADMITTED TO THE TOURNAMENT WILL BE DIVIDED INTO 4 ROUNDS BY 3 TEAMS EACH.

INTO THE ELIMINATORY ROUND THE TEAMS WILL PLAY AGAINST ONLY ONE TIME, FINAL RANKING METHOD ITALIAN POINT.

THE WINNER OF EACH ROUNDS WILL PLAY SEMIFINALS, AND THE WINNER OF THE SEMIFINALS WILL PLAY THE FINAL.

THE TEAMS THAT LOST SEMIFINALS, WILL BE CONSIDERED BOTH AT 3rd PLACE.

ART. 8 CLASSIFICATIONS

THE CLASSIFICATIONS WILL BE DRAWN UP ACCORDING TO THE FOLLOWING CRITERIA:

- 3 POINTS FOR VICTORY
- 1 POINT FOR DRAW
- 0 POINTS FOR DEFEAT

IN CASE OF EQUAL SCORE, THE CRITERIA IN ORDER LISTED ARE VALID:

1. RESULTS OF THE DIRECT MATCHES
2. DIFFERENCE GOALS INTO DIRECT MATCHES
3. DIFFERENCE GOALS INTO THE TOTAL GAME OF THE ROUND
4. MORE NUMBER OF GOALS DONE ON THE TOTAL OF THE MATCHES DISPUTED IN THE ROUND
4. DISCIPLINE CLASSIFICATION
6. LOTTERY DRAW

ART. 9 TIMES OF THE GAMES

THE GAMES WILL BE ORGANIZE IN 2 (TWO) TIMES OF THE DURATION OF 30 (THIRTY) MINUTES EACH

THE GAMES ARE 11 vs 11 ON FIELDS OF REGULAR DIMENSIONS, WITH REGULAR DOORS AND USE OF BALLS N ° 5

ART. 10 PENALTY KICKS (ONLY IN SEMIFINALS AND FINAL).

IN SEMIFINALS AND FINALS, IN CASE OF EQUALITY AT THE END OF TWO REGULATORY TIMES, PROCEDURES WILL BE PERFORMED TO THE EXECUTION OF THE KICKS OF RIGOR WITH THE MODALITIES ESTABLISHED BY THE RULE 14 OF THE GAME RULES AND OF THE OFFICIAL DECISIONS.

ART. 12 ARBITRATORS

THE RACES WILL BE DIRECTED BY ARBITRI F.I.G.C. / A.I.A.

ART. 13 TOURNAMENT COMMITTEE

A TOURNAMENT COMMITTEE WILL BE PREPARED, WHICH WILL BE RESPONSIBLE FOR ANY DISPUTE, PROTEST, CLAIM OR UNFORESEOUS CIRCUMSTANCE.

THE COMMITTEE WILL NOT ACCEPT PROTESTS OR COMPLAINTS ON DECISIONS TAKEN BY ARBITRATORS

THE COMMITTEE WILL PROVIDE TO REPORT TO ITS NATIONAL OR INTERNATIONAL FEDERATION FOR ADOPTING THE MEASURES CONSIDERED EVERY PLAYER AND EVERY MEMBER OF THE PARTICIPATING DELEGATIONS BELIEVED OF BAD GUARANTEES OF UNSPORTSMANLIKE DURING THE TOURNAMENT

ART. 14 DISCIPLINE OF THE TOURNAMENT

THE DISCIPLINE OF THE TOURNAMENT IS ENTRUSTED TO THE SPORTS JUDGE HOLDER OR SUPPLEMENT OF THE COMPETENCE COMMITTEE.

ART. 15 AUTOMATION OF SANCTIONS

THE AUTOMATION OF THE SANCTIONS IS PROVIDED WITH THE FOLLOWING METHODS:
THE PLAYER EXPANDED DURING A COMPETITION WILL NOT PARTICIPATE IN THE NEXT RACE
SAVED MORE SANCTIONS INFLICTED BY THE SPORTS JUDGE; THE PLAYER WHICH IN THE
COURSE OF THE TOURNAMENT ENCOURAGES IN THE SECOND ADMONITION WILL BE DISPLAYED
FOR A COMPETITION ON THE DECLARATORY OF THE SPORTS JUDGE

ART. 16 COMPLAINTS

ANY COMPLAINTS MUST BE PRESENTED WITHIN 30 MINUTES FROM THE END OF THE
COMPETITION ACCOMPANIED BY THE 52.00 EURO TAX; COPY OF THE COMPLAINT MUST BE
DELIVERED TO COUNTERPARTS ALWAYS IN TERMS OF 30 MINUTES.

ART. 17 INSURANCE

IT IS RESPONSIBILITY FOR EVERY PARTICIPATING PARTNER (EVERY FOOTBALL TEAMS) TO
ENSURE THE COVER INSURANCE TO OWN PLAYERS.
THE ORGANIZATION OF THE TOURNAMENT IS RESPONSIBLE FOR THE REGULARITY OF
INSURANCE COVERAGE.

THE GAMES ARE PLAYED ACCORDING TO THE RULES OF THE INTERNATIONAL FOOTBALL
ASSOCIATIONS BOARD (IFAB) CURRENT EDITION.

ART. 19 GENERAL RULES
